1. For all Classes, the entry fee is \$20.00 unless otherwise Stated.
2. 50% from the stake Classes entry fee will be paid back as : 45%, 30%, 15%, 10%, unless otherwise stated.
3. There will be a \$20 emergency medical service/grounds fee.(except Leadline)
4. Classes must have 3 or more entries to compete. Show Management reserves the right to limit entries in any class or division, to refuse, accept conditionally, or to cancel any entries, disqualify any exhibitors, and cancel award prizes, without any claim for damages, to add a dotted line, to cancel or combine any unfilled classes.
5. USEF rules apply.
6. Returned checks will be charged \$40.00
7. Dogs must be leashed at all times.
8. **Proof of Negative Coggins test, rabies certificate, and EHV vaccine must be provided with entry.**
9. All riders must wear properly fitting ASTM and SEI headgear with harness secured when riding anywhere on the show grounds.
10. Kocher Equestrian Center, LLC, employees and property owners will not be responsible for any accidents, loss or damages which may occur to any horse, rider, spectator, groom or equipment before, during, or after the horse show.
11. All divisions are CPHC recongnized.

1. Leadline – Open to riders that have not reached their 7th birthday as of December 1, 2019. Entry \$15.00 No grounds fee

5-8. Short Stirrup Equitation- Open to juniors that have not reached their 11th birthday as of December 1, 2019. Cannot jump higher than 2' at this show. Fences 18" to 2'.

9-12. Beginner Rider Equitation- Open to rider who have not shown over 2' courses. Fences 18" to 2'.

35-36. Low/Adult/Low Childrens Equitation- May not compete in the Adult/ Childrens Hunter and/or Adult/Childrens Equitation. Horses 2'6" Ponies 2'.

47-48. Childrens Pony Equitation- Open to riders who have not reached their 18th birthday as of December 1, 2019. Large 2'6" , Small/Med 2'.

53-54. Childrens Equitation- Open to riders who have not reached their 18th birthday as of December 1, 2019. 3'

59-60. Adult Equitation – Open to Amateur riders.

82-85. Long Stirrup Equitation- Open to non pros. WT, WTC, Fences 18"

2-4. Mini Stirrup- Open to riders that have not reached their 10th birthday as of December 1, 2018. May cross enter into walk trot classes only.

13-15. Pleasure Hunter – Open to horses/ponies showing under hunter seat tack.

19-22. Modified Hunter - May not compete in any division 3' or more in height. Trotting Permitted. Fences 2'- 2'3. NO OXERS.

27-30. Thoroughbred Hunter- Open to all TBs. Fences 2'3"

31-34. Special Hunter- Open to horses/ponies regardless of experience. Fences 2'6"

37-40. Low Adult/Low Childrens Hunter – Same specs as the Low Adult/Low Childrens Eq.

49-52. Childrens Pony Hunter – May Not compete in the Pre Childrens Hunter Division Fences Small/Medium 2' Large 2'6"

55-58. Childrens Hunter – May not compete in the Pre Childrens Hunter Fences 3'.

61-64. Adult Amateur Hunter- Open to Amateur riders. May not Compete in Pre Adult Hunter Division. Fences 3'

65-68. Low Hunter / Open Hunter- Open to horses/ponies regardless of experience. Fences 3' or 3'3" or 3'6". If enough Low 3' height division will be split out.

86-89. Long Stirrup Hunter- Open to Non Pros. Fences 18" Hunt

90-93. Short Stirrup Hunter- Open to juniors that have not reached their 11th birthday as of December 1, 2019. Cannot jump higher than 2' at this show. Fences 18" to 2'.

70-72 Puddle Jumpers – Open to all. Fences 2'

73-75 Special Jumpers – Open to all. Fences 2'3"-2'6" (.70-.75M)

76-78 Low Jumpers – Open to all. Fences 2'9"-3' (.85-.95M)

79-81 Low Child/Adult Modified Jumpers – Fences 2'9"-3". (.85-.95M) Open to horses or ponies ridden by riders who have not reached their 18th as of December 1st, 2019 or by an Adult Amateur.
